Mrs. Caudle:

- Our School will be hosting the Regional CIHS Meeting one day the week of March 12 -16, 2018.
- Principals and County Officers had meeting on Friday, January 19, 2018 about days missed due to winter weather, virtual days will not be a possibility because most of schools in county are not 1:1 and only 64% of county students have access to WiFi.
