**NOTICE: THIS IS A FEDERAL FUNDED SOLICITATION** This Request for Proposal (RFP) is a solicitation for services requiring the expenditure of Federal Financial Assistant funding. Contracts funded with federal grant or loan funds must be procured in a manner that conforms with all applicable Federal laws, policies, and standards, including those under the Uniform Guidance (2 C.F.R. Part 200).

**PURPOSE:** Henderson County Public Schools (HCPS) is receiving proposals from nursing agencies to provide in-school nursing services to students for the 2026-2027 school year. Nursing services are required in students' individualized education plans for 504 plans to ensure students' health, safety, vitality, and access to educational opportunities for students with significant medical needs. This includes, but is not limited to, medical services students require in the classroom, as well as, on the school bus.
