- Require positive / presumptive / close contact students and staff to quarantine according to local protocol
- Employ social distancing to the fullest extent possible
- Require and encourage the proper wearing of face coverings
- Provide information and assist in facilitating vaccination clinics
- Maintain designated sick areas at all sites
- Implement increased hygiene efforts - handwashing, frequent cleaning of high touch areas, daily deep cleaning and sanitization of facilities and buses
- Provide adequate supplies to support mitigation efforts (hand sanitizers, soap, paper towels, etc)
- Limit visitors in schools, when necessary and appropriate, and require visitors wear face coverings
- Post recommendations for face coverings/social distancing/hygiene

Universal and correct wearing of masks

Currently require universal wearing of face coverings/masks in all indoor facilities.

Modifying facilities to allow for physical distancing (e.g., use of cohorts/podding)

- Use visual cues to maintain social distancing
- Increase distance for cafeteria and bus seating to the fullest extent possible

Handwashing and respiratory etiquette

The District will continue to:

- Educate staff on handwashing and respiratory etiquette
- Have staff provide age-appropriate modeling and instruction for students in hygiene
- Install additional hand sanitizer dispensers

Cleaning and maintaining healthy facilities, including improving ventilation

The District will continue to:

- Conduct frequent cleaning of high touch areas
- Employ additional custodial staff
- Provide supplies for classroom teachers
- Electrostatic spray of buses and high touch areas
- Address maintenance and mitigation of HVAC systems
- Encourage and facilitate outdoor instruction

Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments

School health staff will continue to partner with the local health department to develop and implement procedures for notification, contact tracing and quarantining related to positive cases and exposures

Diagnostic and screening testing

The District will make available rapid antigen tests for symptomatic staff and students, partner with local health/medical entities to continue provision of diagnostic and screening testing, and communicate resources to stakeholders

Efforts to provide vaccinations to school communities

The District will continue to:

- Partner with local health department to provide information on and opportunities to receive vaccinations
- Have school health personnel and other school personnel participate in community vaccine clinics, where appropriate

Appropriate accommodations for children with disabilities with respect to health and safety policies

The District will continue to:

- Allow exceptions for individual student needs for face coverings
- Provide ability-level instruction to aid students with tolerance to face coverings
- Provide additional PPE for staff and students
- Offer clear masks / safety shields to aid in communication with students and when working in close proximity

Coordination with State and local health officials

District will continue to work with state and health officials in the following ways:

- School official is a member of the local county government Emergency Operations Team
- School health staff and administrative participation in weekly meetings with local health department to monitor current conditions, respond to issues, and implement contact tracing and quarantining protocol
- Regular meetings with state officials on changing advice and guidelines maintain open information and communication lines with stakeholders
- Attend all NC DHHS meetings to receive updates and latest information on prevention and mitigation
- School staff will participate in vaccine clinics, and assist with information and resource dissemination

The District will continue to:
