MINUTES September 8, 2025

The Henderson County Board of Public Education held a meeting on Monday, September 8, 2025 beginning at 4:00 pm, at 414 4th Avenue West, Hendersonville, NC. The meeting was accessible to the public via a livestream link at, http://hcpsnc.org/live.

CALL TO ORDER

Chairperson Dr. Kathy Revis called the meeting to order at approximately 4:07 p.m. Dr. Revis requested everyone present to stand as the North Henderson High School Air Force JROTC presented the colors. Dr. Revis led those in attendance in the pledge of allegiance.

MOMENT OF SILENT REFLECTION

Dr. Kathy Revis asked those present to remain standing and take a moment of silent reflection.

AGENDA APPROVAL

Dr. Kathy Revis acknowledged receipt of the meeting agenda and called for a motion to approve it as presented. Mr. Blair Craven moved to approve the agenda as presented. Mrs. Amy Lynn Holt seconded the motion. (*Unanimously approved*)

ELECTION OF VICE CHAIR

Dr. Kathy Revis opened the floor for nominations for Vice Chairperson. Mr. Blair Craven nominated Mrs. Amy Lynn Holt, and the nomination was seconded by Mrs. Stephanie Cantwell. With no further nominations, Dr. Revis called for a vote. The Board unanimously elected Mrs. Amy Lynn Holt as Vice Chairperson. Mrs. Holt will serve in this role through December 2025 when new Board Officer elections will take place.

STUDENT/STAFF RECOGNITIONS

Cody Merriman of Glenn C. Marlow Elementary has been named the Slater Family Honored Educator Scholar for 2025–2026 by the Development Foundation of the North Carolina Center for the Advancement of Teaching (NCCAT).

Hendersonville Elementary was officially recognized by the State Board of Education in Raleigh as a Model STEM School of Distinction, the highest designation a STEM school can achieve. The school is the first in North Carolina to complete the Redesignation process, marking nearly a decade of excellence in STEM teaching and learning.

PROGRAM HIGHLIGHT - HCPS Project GLAD- Regional Training Center

Ms. Simone Wertenberger presented to the board updates about HCPS Project GLAD (Guided - Language - Acquisition - Design). Henderson County Public Schools has partnered with OCDE Project GLAD and is a certified regional training center. Project GLAD is a rigorous professional development model that uses current brain research, cultural responsiveness and language acquisition processes to design learning opportunities to help ensure student success. The model is beneficial for all academic language learners, but is essential for multilingual learners. HCPS is 1 of 4 Regional Training Centers in the country and 1 of 2 training centers east of the Mississippi. *No action was taken*.

BOARD MEMBERS' OBSERVATIONS

Dr. Kathy Revis warmly welcomed new board member Stephanie Cantwell to the Board of Public Education.

Mrs. Beth Campbell shared her excitement about welcoming the Class of 2038 by handing out kindergarten t-shirts and noted what a strong start it has been to the school year.

Mrs. Shelia Dale highlighted the positive school culture she observed at Hendersonville High School, particularly praising the leadership of Ms. Laura Bruegger. She noted that the shop program was busy constructing benches for the courtyard. She also reflected on her visit to North Henderson High School, where she toured Ms. Frank's health science classroom and loved the visit.

Mrs. Amy Lynn Holt highlighted the Class of 2038 t-shirt distribution at Clear Creek Elementary, where current HCPS seniors were in attendance and the t-shirt distribution was explained to kindergarteners in a storytime format. She also gave a shout out to the kindergarten distribution at Edneyville Elementary, where one of her favorite moments was giving a shirt to a student in the EC classroom.

Mrs. Stephanie Cantwell shared about her school tour at Sugarloaf Elementary, where she was inspired by Ms. Morrow, who advanced from a teacher assistant to teacher through dedication and hard work. She also noted how much she enjoyed one of her favorite annual traditions, the kindergarten t-shirt distributions.

PUBLIC COMMENTS

At 4:40 p.m. Dr. Kathy Revis opened the meeting for public comment. Seven people addressed the Board. Public comments ended at 5:05 p.m. *No action was taken*.

CONSENT AGENDA

Dr. Kathy Revis cited the Board's receipt of the Consent Agenda presented for approval upon recommendation of the Superintendent. Prior to the meeting, Board members received documentation relative to the Consent Agenda as follows:

Mr. Blair Craven moved to remove item "E. Carolinas Academic Leadership Network" from the Consent Agenda and place it under New Business as item "C." The motion was seconded by Mrs. Amy Lynn Holt and unanimously approved. Dr. Revis then called for a motion to approve the remainder of the Consent Agenda. Mr. Blair Craven so moved, with a second from Mrs. Amy Lynn Holt, and the motion carried unanimously.

OLD BUSINESS

A. Instrument Funding – (Dr. Shannon Marlowe, Assistant Superintendent)

Assistant Superintendent for Instructional Services Dr. Shannon Marlowe shared a follow up with the board about musical instrument funding. Directives from the August board meeting regarding instruments were to begin building up classroom sets of 7th grade instruments for student use in both band and strings. When complete, begin 8th grade, develop a process by which teachers who need capital instruments may submit a request in February of each school year, provide a list to the Board of per instrument cleaning and per instrument repair costs for review. This could lead to additional discussions around funding or cleaning fees for instrument use. The Board's intent is for all instruments to be in the hands of students, and students should not need to share instruments. Dr. Marlowe shared considerations and feedback from teachers which included, available storage space for additional instruments in each school and plans for cleaning and repair of the increased number of instruments, classroom size to support increased numbers of participants and school scheduling to allow for numbers of participants. The Board also requested a purchase and replacement plan to guide future purchases and budget allocations.

Mr. Blair Craven moved to dedicate the remainder of the approved 2025-2026 Instrument Replacement funds toward the purchase of instruments for the middle school band and strings programs. Mrs. Amy Lynn Holt seconded the motion. (*Unanimously approved.*)

NEW BUSINESS

A. Action – 2025- 2026 Initial Budget & Slides – (Mr. Bernie Sochia, Chief Finance Officer)
Chief Finance Officer Bernie Sochia presented the 2025-2026 Initial Budget Resolution for approval. Mr. Sochia stated that this serves as the beginning budget for all funds for subsequent amendments. The total Local Current Expense and Capital Outlay Funds are consistent with the 2025-26 Preliminary Budget previously approved. The State Public School Fund reflects the most current dollar and position allotments as directed by the State. Likewise, the Federal Grants Fund reflects the budgets as approved by DPI to date. The Child Nutrition and Child Care Enterprise Funds reflect continuation budgets with adjustments for all legislative updates approved and anticipated and Board approved changes.

Mr. Blair Craven moved that the Henderson County Board of Public Education approve the Initial Budget Resolution for the fiscal year ending June 30, 2026. Mrs. Shelia Dale seconded the motion. (Unanimously approved.)

- B. Action Contracts/ Purchases over \$90,000 (*Mr. Bernie Sochia, Chief Finance Officer*) Chief Finance Officer Bernie Sochia presented contracts/purchases over \$90,000 for Board approval. Pursuant to board policies 6420, Contracts with the Board, and 6430, Purchasing Requirements for Equipment, Materials, and Supplies, any purchases or contracts in excess of \$90,000 must be approved by the Board. The following purchase was presented for approval: Carolina Thomas 2026 Thomas 72 passenger activity bus as presented in the 2025-26 capital outlay budget.

 Mr. Blair Craven moved that the Henderson County Board of Public Education approve the activity bus purchase as presented. Mrs. Alyssa Norman seconded the motion. (*Unanimously approved.*)
- C. Action Carolinas Academic Leadership Network (*Dr. Kathy Revis, Chairperson*)

 During the August 4, 2025 Board meeting, Chairperson Dr. Kathy Revis shared information about Carolinas Academic Leadership Network CALN) with the Board. CALN is a nonprofit organization dedicated to supporting K–12 public school board members in North Carolina and South Carolina. Dr. Revis shared per Board Policy 2123 Board Member Opportunities for Development states unless otherwise approved by the board, such training must be provided by the following entities: the school system, the North Carolina School Boards Association, the Consortium of State School Boards Associations, the School of Government at the University of North Carolina at Chapel Hill, or the Department of Public Instruction. If a board member wishes to receive training credit or be reimbursed for attending training offered by another entity, he or she must obtain approval from the board prior to participation.

Dr. Revis asked for a motion to approve professional development courses offered by the Carolinas Academic Leadership Network. Mrs. Amy Lynn Holt moved that the Henderson County Board of Education approves that professional development courses offered by the Carolinas Academic Leadership Network will be accepted as training credits for Board of Education members for the 2025-2026 school year. Mrs. Shelia Dale seconded the motion. (*Unanimously approved.*)

B. ACCOUNTABILITY REPORT – (Dr. Shannon Marlowe, Assistant Superintendent)

Assistant Superintendent for Instructional Services Dr. Shannon Marlowe updated the board on the 2024-2025 state accountability results released last week. Dr. Marlowe stated that 17 of 23 schools met or exceeded growth targets (74% of HCPS), 5 Schools Exceeded Growth: Sugarloaf Elementary +2.19, Apple Valley Middle +3.19, East Henderson High +3.45, North Henderson High +9.37, HC Early College +3.88. 12 Schools Met Growth: Bruce Drysdale Elementary +1.70, Clear Creek Elementary +0.29, Etowah Elementary +0.13, Fletcher Elementary -2.00, Hendersonville Elementary -0.71, Hillandale Elementary -1.37, Glenn C. Marlow Elementary -1.54, Mills River Elementary +1.50, Upward Elementary -1.45, Hendersonville Middle -1.23, Rugby Middle +0.19, Hendersonville High +0.83. The General Assembly requires districts to assign grades to schools. The formula used to determine the school grade is 80% proficiency and 20% growth.



Dr. Marlowe shared the overall proficiency for Western North Carolina districts, Henderson County is ranked 5th in the Western region out of 18 districts. HCPS reached its highest graduation rate in district history, at 93.6%, ranking 9th among all North Carolina school districts.
